**Pennsylvania's FY21 Title II Formula Grants Program Application and 3-Year Plan**

**Reporting Period: October 1, 2021 through September 30, 2025**

The Pennsylvania Commission on Crime and Delinquency utilizes the Title II Formula Grant Funds to support priorities identified in our State Advisory Group's (SAG) Plan to the Governor. PCCD is required under 71 P.S. §1190.23 to *"prepare and, at least every two years, update a comprehensive juvenile justice plan on behalf of the Commonwealth based on an analysis of the Commonwealth's needs and problems, including juvenile delinquency prevention."* The Juvenile Justice and Delinquency Prevention Committee, Pennsylvania's SAG, is responsible for developing this Plan.

The Title II 3-Year Plan is the basis of and adheres to the SAG-identified priorities.

Pennsylvania's identified priorities/goals:

- Ensure compliance with the core requirements within the federal Juvenile Justice and Delinquency Prevention (JJDP) Act;
- Build upon our foundation for a comprehensive delinquency and violence prevention strategy by working with state partners, schools, and service providers to better address the needs of Pennsylvania's youth and families;
- Implement and maintain Pennsylvania's highly regarded Juvenile Justice System Enhancement Strategy;
- Address key legislative and policy matters of critical importance to the achievement of these goals;
- Support the needs of juveniles between the ages of 10 and 17, focusing on System Enhancement, Evidence-based Programs and Practices, Delinquency Prevention and Intervention, Identifying/Reducing Racial and Ethnic Disparities (R/ED), and Aftercare/Reentry; and support policies and programs that serve all system-involved adolescents regardless of race, ethnicity, gender or gender identification with services that address prevention, treatment, and reentry needs.

Pennsylvania's Formula Grant Funds support projects related to Compliance Monitoring (R/ED and secure holding procedures), Prevention, Diversion, System Improvement, and Aftercare. PCCD supports activities dedicated to monitoring compliance with the core protections of the JJDP Act, supports programs for local R/ED assessment efforts to reduce racial and ethnic disparities, and prevent formal system involvement.

The Formula Grant Funds support one full-time position directly focused on the Compliance Monitoring requirements of the JJDP Act – through a non-competitive sub-grant. Other funds are awarded through competitive RFPs specific to each of the initiatives identified above. As required, successful applicants report process and intermediate outcome data through the Egrants System – PCCD's electronic grant management system. Reports are required on a quarterly basis and each report is reviewed to ensure that the data is consistent with the goals outlined in each applicant's sub-grant award. Funding is not utilized to conduct research.

C. Provide training (to the extent necessary) to those persons required by this condition to be notified of the award requirement for employment eligibility verification and of the associated provisions of 8 U.S.C. 1324a(a)(1).

D. This prohibition applies also to an Acting Chair, or other person assuming the duties and responsibilities of the Chair, whether permanently or on a temporary basis.

The recipient agrees that, consistent with applicable State law, staff directly associated with administration of the OJJDP Formula Grants Program will attend and participate in conferences, workshops, training sessions and other national or regional meetings deemed by OJJDP to be critical to the administration of this Program. OJJDP will determine which staff and the number of staff that should attend each meeting, consistent with the scope and subject matter of the meeting. Cost of attendance will be borne by the recipient as an administrative cost to the grant or paid from State Advisory Group set aside funds under Section 222(d), as appropriate.

The recipient may not obligate, expend, or draw down funds until the recipient has submitted a revised budget and budget narrative reflecting the total amount of this award, and an Award Condition Modification (ACM) has been issued to remove this award condition.

### 39

The grantee agrees that not later than 60 days after the date on which the award is made (or, if applicable, 60 days after OJJDP releases a grant condition requiring a revised state plan), the grantee shall make the state plan or amended plan required under 34 U.S.C. 11133(a), and submitted as part of the application for this award, publicly available, by posting it on the state's publicly available website.

### 40

Required monitoring of subawards. The recipient must monitor subawards under this award in accordance with all applicable statutes, regulations, award conditions, and the DOJ Grants Financial Guide, and must include the applicable conditions of this award in any subaward. Among other things, the recipient is responsible for oversight of subrecipient spending and monitoring of specific outcomes and benefits attributable to use of award funds by subrecipients.
