North Central Secure Treatment Unit (NCSTU) Girls Program provides secure treatment programming for adjudicated delinquent females age 13–20. Located in Montour County, the Girls Program offers a wide range of services designed to meet the diverse needs of its residents including specific programming for substance abuse and criminal behavior issues, gender-responsive services for female offenders, programming for residents having lower cognitive functioning, and treatment for issues related to chronic delinquent behavior and mental health disorders. All treatment services and aftercare planning incorporates a Balanced and Restorative Justice (BARJ) perspective.

There are currently two Girls Programs located at the NCSTU. Both the Green and Reed Buildings can house up to 24 residents. Each building has two 12 bed units provides female offenders with treatment and services targeting delinquency, trauma, loss, and mental health disorders. The program's mission is to provide a safe, supportive environment while encouraging and empowering young women to lead healthy lifestyles that promote dignity, integrity and responsibility.

The Central Susquehanna Intermediate Unit (CSIU) provides the educational services at NCSTU Girls Program. All residents participate in educational instruction and have the opportunity to obtain credit toward graduation, earn a high school diploma or GED. The school year includes 180 instructional days over 11 months (August through June) and the average length of enrollment is 9 to 12 months. There are five class periods which provide a minimum of five and one half hours of instruction per day (990 hours per school year). Upon admission, residents meet with the school counselor. Each resident establishes an educational goal in conjunction with any court ordered mandates (some judges will order that the resident pursue a GED). Past educational records are reviewed, educational assessments to determine level of instruction are conducted and the Individual Education Plan is completed. In addition to math, social studies, science and English, students attend physical education classes and have the opportunity to participate in the cosmetology or culinary arts program. Post secondary education in the form of on line courses are offered as well, for residents who earn their high school diploma or GED.

The SPEPTM and <u>Performance Improvement</u>

The intended use of the SPEPTM is to optimize the effectiveness of reducing recidivism among juvenile offenders. Recommendations for performance improvement are included in the service Feedback Report, and these recommendations are the focus of the Performance Improvement Plan, a shared responsibility of the service provider and the juvenile probation department.

The CSIU School received a 76 for the Basic Score and a 95% Program Optimization Percentage. These Basic Scores represent an increase of 10 point(s) from the initial SPEPTM Assessment. These POP Scores represent an increase of 12 percentage point(s) from the initial SPEPTM Assessment. The service was classified as a Group 2 service; Remedial Academic Training Service Type. There is a qualifying supplemental service of Job-related interventions found in the research, which was used to enhance this service. The Quality of Service Delivery was found to be at a High Level. For Amount of Service, 68% of the youth received the recommended targeted weeks of duration and 100% of the youth received the recommended targeted contact hours for this service type. The Risk Levels of Youth admitted to the service were: 0% low risk, 44% moderate risk, 49% high risk, and 7% very high risk. The service could improve its capacity for recidivism reduction by addressing the following recommendations:
