Chairman Charles Ramsey called the March 8, 2017 meeting of the Pennsylvania Commission on Crime and Delinquency (PCCD) to order at 10:06 a.m. A quorum of members was present. The first order of business was to review the Minutes from the December 14, 2016 Meeting. Commissioner Damiani made a motion to approve the minutes from the December 14, 2016 PCCD meeting as submitted. Commissioner Ryan seconded the motion and the minutes were approved by unanimous vote.

The next item on the agenda was the <u>Chairman's Report</u>. Newly-appointed Chairman Ramsey introduced himself to the Commission, and encouraged members to bring any issues they feel are not getting the proper attention to him. Chairman Ramsey would like to see at least one quarterly Commission meeting held outside of Harrisburg every year, possibly including a visit to a site funded by PCCD, to get a feel for what is happening in the field. Chairman Ramsey also thinks it is important to recognize those agencies that are doing a good job to improve the lives of residents in the Commonwealth.

Next on the agenda was the Executive Director's Report. Derin Myers said the final meeting of the Justice Reinvestment Initiative (JRI) working group was held immediately after the December Commission meeting. The working group considered the overall framework presented by the Council of State Governments (CSG), and approved it to be presented during the 2017 legislative session. The framework revolves around the concepts of saving money by making short state prison sentences more predictable, investing those savings in more effective county probation, and improving the pre-trial and sentencing policies in Pennsylvania. The projected overall savings is \$110 million in corrections costs. The legislation is currently going through drafting and review. The part of this initiative that would most significantly impact PCCD is the creation of a County Adult Probation Advisory Committee to develop standards for probation and parole, develop an overall county probation funding plan, and reviewing grant applications.

Next, Mr. Myers said the Governor's proposed budget includes a \$10 million increase to provide Naloxone to all first responders in the state. PCCD would have to develop a distribution plan covering a two-year period. There is also \$3.3 million in the budget to support the operation of drug courts. If that makes it to the final ratified budget, PCCD will coordinate with the Administrative Office of Pennsylvania Courts (AOPC) on how to best make those resources available. There is a need for additional resources to support treatment services and provide supervision for those participating in drug courts.

Mr. Myers said the Commission has discussed its efforts to support the city of Chester at previous meetings. In February, Mayor Kirkland invited PCCD and other stakeholders to participate in a meeting to discuss options related to the violence in the city. After the meeting, the Delaware County District Attorney committed to establishing a multi-point strategy to help the city. PCCD offered its resources in terms of pulling people together, planning, and implementing a strategic plan. There are reentry efforts in place, and PCCD continues to make itself available to Chester to help in any way it can.

Mr. Myers noted that Chairman Ramsey and Attorney General Shapiro are interested in continuing the work of the PA Law Enforcement Executive Policy Board and will co-chair this committee. As the bodyworn camera legislation received consideration last year, it was very helpful and productive to have this group share their perspective. The group will convene in the next several weeks.

Finally, Mr. Myers said the Governor has taken steps to address the revenue shortfalls in Pennsylvania relative to complement control. PCCD has experienced this, particularly relative to the victims' compensation program.

Major Scott Price offered an update on a project that the Pennsylvania State Police (PSP) worked on with PCCD. Pennsylvania is a point of contact state for firearms background checks, meaning the

Commonwealth handles their own checks rather than relying solely on the National Instant Criminal Background Check System (NICS). There has always been a concern about the disparity in information available to federal entities versus state entities. In 2016, Attorney General Loretta Lynch encouraged states to become point of contact states due to the dearth of records in the federal system, and/or to consider submitting additional records to NICS. Very often, the Federal database does not have all the records Pennsylvania does for a variety of reasons, such as juvenile records or fingerprint histories rejected by the feds due to poor fingerprint quality. Back in 2014, PSP worked with Bob Merwine and the Office of Criminal Justice System Improvements (OCJSI) to procure a National Criminal History Improvement Program (NCHIP) grant for a NICS Index Submission project. PSP was awarded \$289,000 in NCHIP funds to build a conduit to submit state records to the NICS index. In February 2017, Pennsylvania began submitting and going live with these records. At some point down the road, PSP hoped to be able to bring a concrete example to the Commission of how this public safety vulnerability was being addressed. However, on the very first day there was an email from NICS that an individual was denied the purchase of a firearm out of state as a result of the NICS index submissions. This purchase would not have been denied if PSP and PCCD had not worked on this project. Major Price said there are denials on a nearly daily basis. This is a project that makes a tangible impact on public safety, and it might not have happened without OCJSI's involvement. Commissioner McConnell asked if other states are doing similar projects in support of NICS. Major Price said not every state is participating, and there is no mandate to participate. Some states choose to only submit mental health records. Commissioner McConnell suggested that PCCD make a recommendation to Pennsylvania's legislators to encourage and help other states to participate in NICS.

The next item on the agenda was the <u>Children's Advocacy Center Advisory Committee (CACAC)</u> <u>Report.</u> Kirsten Kenyon said the CACAC's last quarterly meeting was held on February 8, 2017. An overview of the results of a survey on the therapeutic services available for child trauma victims across the Commonwealth which was conducted by the Evidence-Based Prevention and Intervention Support (EPIS) Center at Penn State is included in the meeting materials. Ms. Kenyon also noted that CACAC will soon open a funding announcement for Endowment Act funds to implement multi-pronged, evidence-based child sexual abuse prevention pilot programs in three or four counties in Pennsylvania.

The <u>Criminal Justice Advisory Committee (CJAC) Report</u> was next on the agenda. Commissioner Damiani said the Local Technology Subcommittee has been working with PSP and the Pennsylvania Chiefs of Police Association (PCPA) to implement hand-held, mobile ID devices. All the back-end infrastructure and support is now in place, and the first two production units were rolled out yesterday in Upper Allen Township Police Department in Cumberland County. Next, Commissioner Damiani said PCCD is expected to receive \$288,000 in fiscal year 2017-18 as a result of Act 16, which addresses medical marijuana. CJAC has decided to focus the use of these funds on training for law enforcement in the enforcement on this Act. Commissioner Damiani provided updates on two delegations of authority that were approved at previous Commission meetings. Finally, Commissioner Damiani announced that the 2017 Criminal Justice Advisory Board (CJAB) Conference will be held April 4-5, 2017 at the Penn Stater Hotel and Conference Center.

The <u>Victims' Services Advisory Committee (VSAC) Report</u> was next on the agenda. Commissioner Delaney said it was a privilege to work with Chairman Ramsey again, noting that his appointment as Chairman is a true testament to the Governor and will add significant value to the Commission. In May, the 14th Pathways Conference will be held, where Governor's Pathfinder Awards will be bestowed to individuals and agencies who have delivered outstanding services to victims in the Commonwealth. Next, Commissioner Delaney noted that in 2016, the number of Victims' Compensation Assistance Program (VCAP) claims increased by 13 percent from 2015; the funds awarded increased by 1.4 percent; and staff was able to keep the average processing time below the target of 12 weeks. Lastly, Commissioner Delaney said that due to the significant increase in Victims of Crime Act (VOCA) funds, the federal government has amped up its audit activity, and Pennsylvania is one of the first states to undergo the new intensive audit. The federal auditors have already done the in-house review at the Commission, and are now auditing grantees in the field. Valerie McMahon provided a demonstration of the new Pennsylvania Crime Victim's app, which will roll out on March 27.

The next item on the agenda was the Juvenile Justice and Delinquency Prevention Committee (JJDPC) Report. Mike Pennington recognized Commissioners Jones and Volkman who were recently appointed to JJDPC. Mr. Pennington said copies of the 2017 Pennsylvania Juvenile Justice and Delinquency Prevention Plan are available for the members of the Commission. At least every two years PCCD is required to prepare and update a comprehensive juvenile justice plan on behalf of the Commonwealth based on an analysis of Pennsylvania's needs and problems, including juvenile delinquency prevention. The current plan is the result of 12 months of work and collaboration, and Mr. Pennington recognized Commissioner Anderson for doing a significant amount of the heavy lifting. The plan builds on PCCD's statutory responsibilities and provides a series of recommendations to lay the foundation for a comprehensive delinquency and violence prevention strategy for the Commonwealth. It expedites the implementation of the Juvenile Justice System Enhancement Strategy (JJSES), which focuses on evidence-based practices at all decision-making points of the juvenile justice system. The plan also addresses key legislative and policy matters of critical importance to the achievement of these goals. The two main areas of focus are delinquency prevention and juvenile justice system improvement. The plan contains 11 recommendations. Mr. Pennington invited Commission members to contact Jim Anderson or himself with any questions after they have a chance to review the plan.

Next on the agenda was the Mental Health and Justice Advisory Committee (MHJAC) Report. Commissioner Zottola said Paul Turcotte provided an update on the activities of the Bureau of Autism Services at the last MHJAC meeting. Dr. Richard Cho, Kati Habert, and Will Engelhardt from the CSG Justice Center presented information on the progress of the Stepping Up initiative in Pennsylvania. This initiative is focused on diminishing the number of individuals with mental illness currently incarcerated. Dauphin County has been selected as a designated site for the County Justice and Behavioral Health Improvements Project with CSG. Discussion was held regarding the viability of using MHJAC as the platform to advance the Stepping Up initiative statewide. The Committee agreed that MHJAC should be the vehicle to advance this effort, so a small workgroup will convene to work with CSG on next steps. Dr. Ed Mulvey and Carol Schubert from the University of Pittsburgh presented the findings of their study on the effectiveness of Crisis Intervention Team Training (CIT) in Pennsylvania. Commissioner Zottola noted that the Statewide CIT Meeting will be held March 23-24, 2017 at the Holiday Inn in Grantville. This meeting will include a one-day workshop for CIT teams, as well as a two-day de-escalation Train-the-Trainer.

The <u>Bureau of Training Services Report</u> was next on the agenda. Mr. Merwine said the February meeting of the Constables' Education and Training Board meeting was canceled and has been rescheduled for March. There was one item of note from the Sheriff and Deputy Sheriff Education and Training Board

meeting held last week. The status of the training fund has been trending downward for the past several years. Expenditures have continued to exceed revenues, depleting the reserves. The Board has been monitoring this situation very closely, and has taken some measures to reduce costs over time. By statute, PCCD is responsible to pay for the costs associated with basic and continuing education training for Sheriffs and Deputies, as well as reimbursing the counties for associated costs. Legislation has been introduced to increase the revenue to the training fund. As this legislation is still pending, the Board voted to suspend reimbursements to counties effective July 1, 2017. This will defer the expenses until revenues increase. Commission approval is required in order to do this. Staff will continue to monitor the bill during the spring session and will evaluate the Board's recommendation in order to present an action item to the Commission in June.

Chairman Ramsey asked if there is any <u>Other Business</u>. Commissioner Damiani thanked Mr. Myers and the staff of PCCD for taking an active interest in the City of Chester. Commissioner Dunn asked that the Pennsylvania Board of Probation and Parole (PBPP) District Representative be included in discussions regarding Chester. Commissioner Aguilar said many of the issues presented with respect to Chester are those referred to as social determinants of health, and there is a place for that conversation as well.

Next on the agenda, Chairman Ramsey asked if there was anyone present at the meeting who wanted to make a public comment during the <u>Public Voice</u> portion of the meeting. No one stepped forward to exercise their rights under the Sunshine Law.

The next Commission meeting will be held at 10:00 a.m. on Wednesday, June 14, 2017 at the PCCD Offices.

Commissioner Dunn made a motion to adjourn which was seconded by Commissioner Volkman. The motion carried unanimously and the meeting concluded at 11:23 a.m.
