Chairman Shapiro called the December 9, 2015 meeting of the Pennsylvania Commission on Crime and Delinquency (PCCD) to order at 10:02 a.m. A quorum of members was present. Chairman Shapiro introduced and welcomed Carol Lavery and Pennsylvania Board of Probation and Parole (PBPP) Chairman Michael Green, the newest members of the Commission. The first order of business was to review the <u>Minutes from the September 9, 2015 Meeting</u>. *Commissioner Vereb made a motion to approve the minutes from the September 9, 2015 PCCD meeting as submitted. Commissioner Heckler seconded the motion and the minutes were approved by unanimous vote.* 

The next item on the agenda was the <u>Chairman's Report</u>. Chairman Shapiro said there are over \$20 million in grants on the Commission's agenda for the day, including the first grants under the Endowment Act. The Justice Reinvestment Initiative (JRI) in 2011 yielded funding for the Commonwealth and helped the criminal justice system. To date \$2.8 million has been reinvested from the savings achieved through JRI. There will be \$6.4 million associated with that work in the fiscal year 2016-2017 budget when it is passed. Notice was recently received that Pennsylvania has been approved for JRI 2, and an announcement will be made in early 2016. PCCD will again serve as the hub to bring all the stakeholders together.

Next, Chairman Shapiro said that the Pennsylvania Law Enforcement Executive Policy Board (LEEP) met a month ago at the Governor's Residence to bring together leaders of law enforcement across the Commonwealth to address the challenges facing everyone. Some of those issues included building trust and legitimacy in the criminal justice system; policy and oversight on topics such as body cameras; technology and social media; community policing and crime reduction; officer training and education; and officer safety and wellness. Philadelphia Chief Charles Ramsey, who served as the Chair of President Obama's Taskforce on 21<sup>st</sup> Century Policing, gave a presentation on the Taskforce report.

Chairman Shapiro briefly touched on the opioid and heroin crisis in Pennsylvania. There have been several requests from counties for a coordinated, collaborative response to this issue. In response, PCCD will hold a symposium for all interested parties on Wednesday, January 27, 2016 from 9:00 a.m. to 5:00 p.m. at the Radisson Hotel in Camp Hill. PCCD wants to ensure that every county that is interested in developing programs or protocols has the necessary tools. PCCD has been engaged in this effort in several other ways, including joining Cumberland County District Attorney David Freed for a drug turn-in from their drop boxes which amounted to a total of over two tons of medications, 25 percent of which were opioids. Governor Wolf has been instrumental in making sure Naloxone is available across Pennsylvania, and approximately \$65,000 in PCCD funding is still available for municipal police departments that wish to carry it.

Chairman Shapiro noted that an audit done by Auditor General Eugene DePasquale was positive for PCCD. In fact, the Auditor General commended PCCD publicly in his press release which is an unusual occurrence. Finally, Chairman Shapiro thanked Lynn Shiner for her 37 years of service to the Commonwealth, PCCD and victims in Pennsylvania. She has left an indelible mark on the Commonwealth and Chairman Shapiro wished her the best in the next chapter of her life. Commissioner Delaney said it has been an honor and a privilege to work with Ms. Shiner. Ms. Shiner's commitment, experience, intelligence, dedication, sensitivity, and openness to new ideas have been incredibly rewarding to advocates and victims throughout the Commonwealth as well as to those who have been fortunate enough to work with her personally. Carol Lavery said Ms. Shiner has turned the Office of Victims Services (OVS) into a national leader through her integrity and drive. Ms. Shiner said it has been an incredible experience to work with the staff at PCCD.

Next on the agenda was the <u>Executive Director's Report</u>. Linda Rosenberg said the existing continuing resolution at the federal level will end later in the week. Most likely there will be another continuing resolution, then possibly a CR Omnibus bill which combines a continuing resolution on the appropriation

bills that Congress cannot agree on with an omnibus bill on those they can agree on. The advocates have been reaching out to the Congressional delegation, particularly about Victims of Crime Act (VOCA) funding. It looks like \$1.5 billion will be moved out of VOCA and put into the general fund which would be the first time money was ever taken from the Crime Victims Fund for other purposes. Chairman Shapiro and others have sent letters in an effort to educate Congress that this is a poor idea. PCCD is also keeping an eye on what the final VOCA number will be in the federal budget. This year the federal allocation was \$2.3 billion, with Pennsylvania's share at approximately \$77 million. PCCD is hearing that the proposed VOCA allocation for this year is \$1 billion with Pennsylvania's share in the \$30 million range. In this regard, a continuing resolution would be good as it will keep VOCA funding at a higher level.

Ms. Rosenberg wanted to clarify a few things about the money administered by PCCD and the state budget, because there were a few recent newspaper articles that were simply incorrect. PCCD administers four funding streams for victims' service programs: Rights and Services Act (RASA); STOP Violence Against Women; VOCA; and Victims of Juvenile Offenders (VOJO). All of the funding is administered on a quarterly reimbursement basis. RASA funding is generated by a \$25 penalty assessment fee on convicted and diverted offenders which goes into a restricted receipt account and therefore does not need to be appropriated. About \$6.2 million goes into that account annually. Despite the current budget issues, RASA money has continued to flow to recipients. STOP Violence Against Women is a federal funding stream of approximately \$4.7 million annually. This funding stream typically needs to be appropriated, but Pennsylvania was able to secure waivers from the Governor's Budget Office (GBO) so monies not spent in prior years could be spent this fiscal year. STOP recipients were owed \$1.1 million and PCCD was able to pay out over \$1 million. As far as VOCA funding, PCCD was also able to secure a waiver for about half of the \$5.6 million owed in the first quarter. Two weeks ago PCCD was given authority to spend all of its federal VOCA dollars so all the grantees have now been reimbursed for the first quarter. Ms. Rosenberg said Chairman Shapiro challenged PCCD to leverage the Commission's role as a community of practice for criminal justice related grants, and Ms. Rosenberg updated the Commission on the \$6.5 million in Memorandums of Understanding (MOUs) that are in place with other state agencies to administer grants. PCCD received \$388,000 for the Office of the Safe School Advocate and \$200,000 for the Pennsylvania Youth Survey (PAYS). The County Commissioners Association of Pennsylvania (CCAP) will be awarded \$80,000 per year for three years to provide leadership for the implementation of evidence-based practices in county probation. The Department of Human Services (DHS) has given PCCD \$2.5 million via MOU for the procurement of Naloxone and Vivitrol and a pilot Medication-Assisted Treatment (MAT) project in county corrections; \$265,000 to help support Multi-Disciplinary Investigative Teams (MDITs); as well as additional funding to support PAYS, the Evidence-Based Prevention and Intervention Support (EPIS) Center, and the Pennsylvania Academic and Career/Technical Training (PACCT) program. Chairman Shapiro said the more dollars and programs PCCD can be involved in the more effective the agency can be. This has put PCCD in a position to administer \$6.5 million in funding, and most importantly, to be in the conversation regarding these important issues. This is something that began a few months ago and the Governor and Secretaries have been very receptive. Staff has done a great job of identifying these opportunities. Finally, Ms. Rosenberg said there is currently a hiring freeze and PCCD is suffering like most other agencies. There are a total of 15 vacancies, three of which are Director-level once Ms. Shiner retires. Kathy Buckley has agreed to serve in an acting capacity until the position of OVS Director can be filled on a permanent basis.

The <u>Victims' Services Advisory Committee (VSAC) Report</u> was next on the agenda. Commissioner Delaney said that the VSAC strategic planning process regarding the significant increase in VOCA funds required the committee to meet ten times since last December. Commissioner Delaney acknowledged the support and coordination offered by Chairman Shapiro and Ms. Rosenberg, as well as the participation of a number of Commissioners who participated in VSAC's meetings. Commissioner Anderson helped

facilitate the process and was present at nearly all the meetings. VSAC based its plan on three assumptions: the 2016 federal VOCA allocation will be the same as the 2015 allocation; the foundation upon which the strategy is built should be the creation of a stable and predictable funding mechanism for victims' services; and the strategy should be developed in tandem with how funding is provided to support procedural services in the Commonwealth. VSAC's recommendation includes the funding formulas; the funding framework; and a small but significant set-aside for one position with the Office of the Victim Advocate (OVA).

VSAC recommends the support of one staff position at OVA to coordinate in-person testimony before the parole board not to exceed \$65,000.

1. Commissioner Delaney made a motion for the approval of the VSAC VOCA Strategic Planning Process to include the Funding Formulas and Funding Framework as described and outlined on page three of the meeting materials. Commissioner Green seconded the motion.

Commissioner Minor Wolf asked what will happen if the federal allocation is different than the committee's assumption. Commissioner Delaney said VSAC held a conference call a few weeks ago

to discuss this issue. VSAC discussed potential allocation scenarios and approved three contingency plans that will remain true to the committee's original intent but will reduce the numbers accordingly. Commissioner Rieland asked if there is an estimate of how many new programs will be eligible under the competitive funding pot. Commissioner Delaney said there is no clear idea of what the market will generate in terms of requests for this funding. *With no further discussion or public comment on the motion, Chairman Shapiro called for a vote. Dr. Mulvey looked specifically at risk levels of offenders and who the offenders that recidivate are. Dr. Mulvey also took a preliminary look at the efficacy of the Youth Level of Service (YLS) risk assessment tool and found that it is in fact being effective in accurately predicting recidivism rates, and is especially helpful when combined with the information in the Juvenile Case Management System (JCMS) in assisting courts in making decisions. JJDPC will look further into this data in the upcoming year and thanks PCCD for its continued support of this important work.
