I. Call to Order

The December 14, 2022 meeting of the Pennsylvania Commission on Crime and Delinquency (PCCD) was called to order at 10:02 a.m. by Chairman Charles Ramsey. Roll call was requested. He informed members that the meeting was being recorded, to which there were no objections.

II. Chairman's Report

Chairman Charles Ramsey

- The first order of business was to approve the minutes from the September 14, 2022 meeting.

- Chairman Ramsey opened his report by welcoming new members Joe Hill, Senior Principal for Cozen O'Connor Public Strategies, and Senator Scott Martin, who represents the 13th Senatorial District in Lancaster County and now serves as Chair of the Senate Appropriations Committee. He also acknowledged Terry Trego, Senator Martin's Chief of Staff, who will serve as Senator Martin's delegate.

Chairman Ramsey announced that District Attorney John Adams from Berks County has been reappointed to another term on the Commission.

He then acknowledged the service and contributions of departing Commission members. Anne Ard has served on the Commission since 2019, and recently retired as Executive Director of Centre Safe. Karen Baker has served on the Commission since 2018, and has been appointed by Governor Wolf to serve on the Victims Services Advisory Committee. This will also be the final Commission meeting for Keith Snyder, JJDPC Chair.

Chairman Ramsey announced that, after nearly six years, he will be resigning as Chairman of PCCD following this meeting. He noted that PCCD's duties and responsibilities have grown significantly throughout his tenure. When he began, PCCD was issuing approximately 500-600 grants a year. To date, we now administer thousands of grants across several new programs, including school safety and security, nonprofit security, county adult probation and parole, violence intervention and prevention, law enforcement support and gun violence prosecution and investigation, and other initiatives.

III. Executive Director's Report

Michael Pennington, Executive Director

- Mr. Pennington thanked Chairman Ramsey for his years of dedicated service, not only to this Commission, but to the field of public safety as a whole. Chairman Ramsey also chaired PCCD's School Safety and Security Committee and was appointed as both the Governor's Special Advisor on Gun Violence and Chair of the Special Council on Gun Violence.
- In this year's budget, the School Safety and Security Committee was tasked with administering \$190 million in formula-based School Mental Health and School Safety Grants. Since September, PCCD staff have been working to process nearly 800 applications submitted by school districts, charter schools, intermediate units, and career and technical centers. Staff have completed initial programmatic reviews of all applications, and we've made several awards to date. We are working to process requests as quickly as possible and have been providing updates to the field on our progress.

The School Safety and Security Committee will reconvene on January 11, 2023. Among the agenda items, the Committee will take action on recommended applications funded through this year's Violence Intervention and Prevention, or VIP, appropriation. Updates on the projects that

are approved, as well as updates on the current cohort of VIP grants, will be shared at future Commission meetings.

The VIP Technical Assistance Project is making strides. Last week, PCCD and partners at WestEd and LISC hosted an informational webinar for grantees on the launch of a new statewide community of practice. This initiative will help connect people and groups working to prevent violence and address its impacts within their communities, and provide high-quality resources, training, and technical assistance opportunities at no cost.

- The Adult Behavioral Health Commission was a task force established after the budget passed to make recommendations as to how to expend \$100 million in funding to support mental health needs in the Commonwealth. It appears that the \$100 million carved out for adult behavioral health initiatives that was approved in this year's budget will be taken up in the next legislative session. If there is interest in reading the Commission's recommendations, which included criminal justice and public safety related initiatives, a copy can be found on the Department of Human Services' website.
- The Task Force on Child Pornography held its final meeting on September 28 and adopted a report of findings and recommendations drafted by the Joint State Government Commission in consultation with PCCD. The recommendations included amending the term "child pornography" in Pennsylvania laws and regulations by replacing it with "child sexual abuse material"; improving access to training for law enforcement officers and county probation officers; offering more equipment to support the investigation of these offenses; and support targeted education opportunities for judges and prosecutors. The final report can be viewed on PCCD's website under the Task Force Reports section.
- Mr. Pennington's final general update was on the federal Byrne State Crisis Intervention Program (SCIP) Funds, which were new funds allocated as part of the federal Bipartisan Safer Communities Act, which was signed by President Biden in June 2022, to support a wide range of programming throughout justice agencies, educational agencies, and behavioral health agencies.

The U.S. Department of Justice (DOJ) recently announced the availability of \$257.8 million in federal funds. These dollars can be used to implement state crisis intervention court proceedings and related programs or initiatives with an overarching goal of reducing gun violence. Pennsylvania is eligible for approximately \$8 million under this formula-based solicitation. As part of this solicitation, DOJ is requiring state applicants form a diverse Crisis Intervention Advisory Board to inform and guide the state's efforts in this space and develop a program plan for use of Byrne SCIP funds. Board members must include representatives from law enforcement, the community, courts, prosecution, behavioral health providers, victim services, and legal counsel. States may utilize existing groups to fulfill this requirement.

Given the structure, composition, and existing work of our Commission and Advisory Committees, PCCD plans to identify our Commission as the entity responsible for oversight of Byrne SCIP funds, and will use a group like our Committee of Chairs to support the development of a funding framework for use of these dollars. We'll also crosswalk previously identified strategic priorities to develop a program plan that can guide the development of a funding framework and can be submitted for approval by the feds. We believe utilizing this existing infrastructure will ensure these much-needed investments can be made in a timely fashion. PCCD will submit our noncompetitive application to BJA on December 19.

- The first action item for consideration is the First Chance Trust Fund Statement of Policy Update, which was included as a separate document at the end of the meeting materials.

In December 2017, the Commission was tasked by Act 44 of 2017 to adopt an original statement of policy regarding the First Chance Trust Fund, which is a fund intended to provide enhanced opportunities to at-risk youth in those areas of the Commonwealth that have higher high school drop-out rates, incarceration rates, or high crime rates. The Act required the Commission to adopt

a Statement of Policy that includes the risk factors that may lead to criminal behavior and provide for the 'maintenance use' of the fund.

When we adopted the original Statement of Policy, we opted to implement the program through the JJDPC, with consultation with VSAC, as that committee was the only one we had at the time familiar with student needs.

Since then, however, we've seen the addition of the School Safety and Security Committee, which contains membership of individuals with direct expertise with students and school administration. As the First Chance Trust Fund supports scholarships to students and/or programs to be implemented in schools to provide assistance to at-risk youth, it made sense to revise the statement of policy to allow for the inclusion of members from the School Safety Committee. Over the past few years, we've also had several members of our Commission express an interest in the program. Based on those factors, we thought that a workgroup of multiple representatives at the Commission level and advisory committee representatives would be appropriate to represent all parties and interests.

The final substantive amendment to the policy was the addition of the depressive symptoms risk factor to the Risk and Protective Framework. That risk factor was added to that listing since the last one was published (which used the listing of factors from the 2015 PAYS) which will make the at-risk factors listing current.

The reason for updating the policy is a timely one because, for the first time in five years, the First Chance Trust Fund has received an allocation from the Pennsylvania Department of Corrections (PA DOC) to trigger the release of funding. The funding mechanism to support the First Chance Trust Fund comes from a 1% contribution from entities having annual contracts with the PA DOC that exceed \$5 million or greater. Earlier this year, an allocation of \$407,106 was received, and it is projected that the Fund may receive regular allocations of at least \$1 million annually over the next four years for the program.

Action Item: First Chance Trust Fund Statement of Policy Update

Staff are requesting approval of the revised Statement of Policy for the Administration of the First Chance Trust Fund.

This revised Statement of Policy will be submitted for printing in the next available PA Bulletin as required by law. Mr. Pennington will be working on putting together the Workgroup to address the First Chance Trust Fund beginning next month, so if any members are interested in serving, please let him know as soon as possible.

- The second action item is the Nonprofit Security Grant Fund Program. The project summary can be found as a separate document at the end of the meeting materials.

As part of the FY22-23 budget, \$5 million in state funding was allocated to support this program, which was established by Act 83 of 2019 to distribute grant funding to 501(c)(3) organizations who principally serve individuals, groups, or institutions that may be susceptible to or have experienced a hate crime. Applicants are eligible for awards ranging from \$5,000 to \$150,000 for a range of physical security enhancements for their facilities.

This will mark our fourth issuance of these funds within three years for this program. A workgroup composed of representatives from PCCD, the Commission Board, the Pennsylvania State Police, and the Governor's Office of Homeland Security considered the review methodology and the requests directly. Priority consideration in the application review process was given to those nonprofit organizations that indicated that their organization or membership was the victim of a hate-crime or clearly justified a credible hate-crime threat to their organization; served a population

clearly susceptible to a hate-crime; and requests from entities that had not received prior funding from either PCCD's or PEMA's Nonprofit Security Grant Program. Prior recipients of PEMA and PCCD funding were also considered for funding if a new incident was cited since previously receiving funding or to meet security improvement recommendations in their physical security assessment.

Action Item: First Chance Trust Fund Statement of Policy Update

93 initial applications requesting a total of \$3,987,450 in state Nonprofit Security Grant Fund Program funds are recommended to be approved, pending the resolution of programmatic and fiscal requirements and any outstanding conditions or concerns.

Mr. Vereb provided brief highlights from the CJAC meeting, held on November 22, 2022 and continued with a brief session on December 2, via Teams, and presented six informational updates and seven action items for the Commission's consideration.

Action Item: Medical Marijuana Act Enforcement Funds

Staff and the Criminal Justice Advisory Committee are recommending approval of ten applications requesting a total not to exceed \$887,698 in state Medical Marijuana Act Enforcement funds, pending the resolution of any outstanding programmatic and/or fiscal concerns.

Action Item: Federal American Rescue Plan Act Funds – Gun Violence Investigation & Prosecution (GVIP) Grant Program

Mr. Vereb noted that, as with all Gun Violence-related grantees, PCCD intends to hold applicants accountable for these funds through the collection of information such as baseline data, process metrics, and other outcome data to help determine the effectiveness of these grants, including information about the improvement of gun violence crime clearance and conviction rates. In addition, as part of the regular programmatic and fiscal review, PCCD will also ask for letters of support, if relevant; program sustainability plans; supplementation; and other related information. Funding will not be released until grant conditions are satisfied.

Outside of these grants, Act 54 also included a provision that PCCD is to work with the Administrative Office of Pennsylvania Courts (AOPC) to obtain as nearly real-time data as possible on all individuals charged with firearm offenses throughout the state and their disposition outcomes, and to use that data to help determine the effectiveness of the grant outcomes. Research will culminate in a public-facing website or dashboard to share this information.

Staff and the Criminal Justice Advisory Committee are recommending the approval of 29 applications requesting a total not to exceed \$50 million in federal GVIP Grant Program funding, pending the resolution of any outstanding programmatic and/or fiscal concerns.
