I. Call to Order

Chairman Ramsey called the September 11, 2019 meeting of the Pennsylvania Commission on Crime and Delinquency (PCCD) to order at 10:00 AM.

Chairman asked everyone to take a moment of silence in remembrance of the victims of 9/11.

Chairman Ramsey welcomed members and guests, and he verified participation by a quorum. He asked for a roll call of members on phone.

II. Chairman's Report

Chairman Charles H. Ramsey

- The first order of business was to approve the minutes from the June 12, 2019 meeting. Commissioner Snyder made a motion to approve the Minutes from the June 12, 2019 PCCD Commission Meeting. Commissioner Storm seconded the motion and the minutes were approved by unanimous vote.
- On Friday, August 16th, Governor Wolf signed an Executive Order to address the issue of gun violence. Chairman Ramsey was asked to serve as senior advisor on gun violence issues and the Executive Order also created the Special Council on Gun Violence at PCCD. The Special Council consists of representatives from each of the agency's advisory committees, including the School Safety and Security Committee; one representative from each of the legislative caucuses of the General Assembly; and the secretaries of Education, Health, Human Services, State Police, and the Director of Homeland Security. The council is tasked with meeting no later than mid-October and is asked to study and provide a report to Chairman Ramsey and the Commission with recommendations to reduce incidents of community violence, mass shootings, domestic violence, suicide, and accidental shootings, within six months of that meeting. The Executive Order also established an Office of Gun Violence Prevention within PCCD, as well as a Division of Violence Prevention at the Department of Health. The Office and Division will work together to blend both a public safety and public health response to all facets of gun violence.
- The Bureau of Justice Assistance (BJA) requires that the Governor of the state certify that the 2019 JAG applications were submitted for review to the governing body of the State, or to an organization designated by that governing body, not less than 30 days before the date of his certification. The Commission is the designated governing body for Pennsylvania's JAG application. PCCD's FY 2019 JAG application is included in the Commission packet beginning on page 55 and is also available for review on PCCD's website. The application was submitted to BJA on July 29, 2019 to support activities and strategies identified in PCCD's 2016-2020 Strategic Framework.

PCCD's 2019/2020 JAG Funding Plan is included in the Commission packet beginning on page 116. The Funding Plan includes the priorities and activities identified through the strategic planning processes of PCCD's Advisory Committees and details the amount of funds available to support Local Share, State Share, and Under \$10K initiatives.

The Committee of Chairs met on August 5, 2019 and voted to approve the 2019/2020 JAG Funding Plan as listed in the meeting materials.

Chairman Ramsey asked if there were any questions on the JAG application or funding plan. No questions were asked, Chairman Ramsey presented the Action Item on Page 127 and asked the Commission for a motion of approval. Commissioner Steele made the motion to approve and his motion was seconded by Commissioner Vereb. No points for discussion were submitted and there were no abstentions. The motion passed unanimously.

III. Executive Director's Report

Derin Myers, Acting Executive Director

Mr. Myers provided updates and an overview of recent activity within PCCD.

- Kathy Buckley has joined PCCD as Director of the Office of Victim Services.
- Since we last met, the state budget passed and all of PCCD's primary appropriations were funded at levels similar to last year Intermediate Punishment at \$18.167M, Violence and Delinquency Prevention at \$4.039M, and Victims of Juvenile Offenders at \$1.3M.
- The School Safety and Security Committee continues to meet and work to implement what is required of them as defined in the school code. The finalized state budget included \$60M for the grant program again this year and those funding announcements are currently open for application. The Committee was also tasked with the development of a model trauma-informed plan that is to be used by school entities when asking for funding to support trauma-informed strategies within the school. The School Code was amended to include the assignment of several new responsibilities to the Commission, including the periodic review of the training that is required of all school security personnel which includes School Police Officers, School Resource Officers and School Security Guards. The current requirement is that all security personnel attend the Basic School Resource officer course offered by the National Association of School Resource Officers (NASRO), however there is an opportunity for the Commission to determine that there is a training program that would be considered a NASRO equivalent. Current NASRO training is five days long and some argue that security guards don't need to attend all five days. We have started to explore this issue with a small group of interested parties.

The other items assigned to the Commission include the development of criteria certifying third party school security guard vendors, publishing on the website those that satisfy the criteria and submitting an annual report to the General Assembly related to school security to include recommendations related to school security personnel training requirements. A recommendation on what should be included in the certifying data will be presented at the December Commission meeting.

IV. CACAC

Honorable David W. Heckler

CACAC has no action items.

• The Honorable David W. Heckler, Committee Chair, provided an overview of the Children's Advocacy Center Advisory (CACAC) report, referencing page 1 of the Commission meeting materials. Chairman Heckler noted that the Committee convened on August 27, 2019 in State College and briefly shared a few highlights of that meeting, including a major status update provided by Dr. Jennie Noll on our Child Sexual Abuse Prevention Pilot Research Project. PCCD uses Endowment Act funding to support the implementation of these programs while Penn State uses their Endowment Act funding to conduct the research. We are currently at the halfway point of the pilot and the main takeaways discussed at the meeting were that the school-based component is progessing very well. The Safe Touches Program is being administered in 98% of all second grade classes in the public schools in each of the subject counties. The community-based component is the biggest challenge as the goal of the project is to get at least 5% of each county's population trained in the Stewards of Children child abuse prevention program. For the Parenting Component, Penn State developed the Smart Parents Safe and Healthy Kids curriculum. They found that this curriculum was effective in improving parent knowledge, attitudes and behaviors. The plan is to roll out this curriculum to the pilot counties within the next year.
