GOVERNOR CORBETT ANNOUNCES COMMISSION APPOINTMENTS, REAPPOINTMENTS










FETC Commissioners Christensen, Yarnell, Schlechter, and Beaver

October 3, 2011 - Governor Corbett announced the appointment of two new Commissioners to the FETC. Commissioner Erik Christensen is a Probation Officer with Erie County Adult Probation and is in charge of that department's officer safety training. He is also the chairman of the FETC's Curriculum Committee. Commissioner John Yarnell is Chief Juvenile Probation Officer for Wyoming and Sullivan Counties. He is also Chairman of the FETC's Policy Committee and a member of the Safety Committee.

Governor Corbett also announced the reappointment of Commissioners Scott Schlechter and Michelle Beaver. Commissioner Schlechter, currently FETC's Chairman, is a supervisor with Lehigh County Adult Probation. Commissioner Beaver is Chief Probation Officer for Juniata County.

FETC Commissioners are each appointed to three-year terms.

originally began advising the FETC while still working for the PBPP and continued in that capacity after accepting the position of CCAPPOAP's Executive Director in 2005.
