1. Requirements of the award; remedies for non-compliance or for materially false statements

4. Required training for Point of Contact and all Financial Points of Contact

Both the Point of Contact (POC) and all Financial Points of Contact (FPOCs) for this award must have successfully completed an "OJP financial management and grant administration training" by 120 days after the date of the recipient's acceptance of the award. The basis for using a cooperative agreement is the substantial involvement of the Bureau of Justice Statistics (BJS) in providing information, guidance, and direction relative to criminal justice information and statistical systems development and modification in the state. BJS will exercise general approval over the entire project. In addition, the substantial involvement of BJS will include, but not be limited to:
 - a. Assisting the recipient in determining the types of statistical information that will be useful to state and local agencies in planning, implementing, and evaluating criminal justice programs.
 - b. Identifying Federal information resources and determining appropriate means of making them available to the recipient or providing access to them.
 - c. Providing technical assistance to the recipient in the interpretation and utilization of Federal statistical data.
 - d. In consultation with the recipient, defining the needs of BJS for information pertaining to justice system topics and operations in the state, determining the availability of such information, and having the recipient provide BJS access to them.
29. Copies of published reports funded in whole or partially by this cooperative agreement will be made available to BJS and JRSA.
30. When requested by BJS, the recipient agrees to provide to the Justice Research and Statistics Association (JRSA) and BJS information on automated data sets which are maintained by the recipient, or which are maintained by other agencies in the state and have been used successfully by the recipient in the past two years for analytic or statistical purposes. The information to be provided for each data set is indicated on the Infobase of State Activities and Research (ISAR) data collection form. To the extent that they are readily available, lists of data elements and/or code books also should be provided. If the recipient already has provided BJS or JRSA with this information, submission will cover only new data sets and the updating of previous data.
31. The recipient shall provide the project manager with a copy of all interim and final reports and proposed publications (including those prepared for conferences and other presentation) resulting from this agreement. Any publications, excluding press releases and newsletters, whether published at the recipient's or government's expense shall contain the following statement: This project was supported by Grant No. _____ awarded by the Bureau of Justice Statistics, Office of Justice Programs, U.S. Department of Justice. Points of view in this document are those of the author and do not necessarily represent the official position or policies of the US Department of Justice. BJS defines publications as any planned, written, visual or sound material substantively based on the project, formally prepared by the recipient for dissemination to the public.
32. At the discretion of BJS, published reports produced under this grant may be: (1) disseminated through the National Criminal Justice Reference Service (NCJRS) as a final grant product to be accessed electronically through the NCJRS abstract database; (2) identified on the BJS website and made accessible through a hyperlink to the grantee website; and/or, (3) posted to the BJS website. Reports submitted by the grantee to BJS for publication must adhere to BJS publications standards. These standards are provided in the guidance documents, -Manuscript Specifications for Reports and Books, BJS- and "BJS Style Guide," available on the BJS website at <<https://bjs.gov/>>.
33. Copies of any published reports funded in whole or in part by this cooperative agreement must be provided directly to BJS and JRSA. The recipient will enter complete and accurate information regarding activities funded by this agreement in the online Infobase of State Activities and Research (ISAR) that is maintained by JRSA.

Within 45 calendar days after the end of any conference, meeting, retreat, seminar, symposium, training activity, or similar event funded under this award, and the total cost of which exceeds \$20,000 in award funds, the recipient must provide the program manager with the following information and itemized costs:

- 3) location of event;
- 4) number of federal attendees;
- 5) number of non-federal attendees;
