On behalf of Attorney General Merrick B. Garland, it is my pleasure to inform you the Office of Justice Programs (OJP) has approved the application submitted by PENNSYLVANIA COMMISSION ON CRIME AND DELINQUENCY for an award under the funding opportunity entitled 2022 FY 2022 State Justice Statistics Program for Statistical Analysis Centers. The approved award amount is \$224,969.

**Project Description**

The Pennsylvania Commission on Crime and Delinquency (PCCD), the designated SAC for the

Commonwealth, will use FY22 SJS funds to support one Core Capacity project to increase access to statistical data by utilizing GIS-mapping, dashboards, and data analytics; and one Special Emphasis project analyzing state criminal history records to statistically validate and review the Ohio Risk Assessment System (ORAS) by linking the recidivism of county supervised offenders on probation/parole to assessed criminogenic risk. The 12-month core capacity project builds upon the successes and enhanced capabilities from previous SJS awards by continuing to use software to facilitate the SAC's ability to conduct complex research and isolate on important data metrics that inform decision-making and guide public policy. The SAC has architected an automated "start-to-finish" data workflow process, which collects, organizes, analyzes, and visualizes data metrics from large, complex, and often disparate/siloed datasets. The data workflow will be used in conjunction with GIS-mapping to enhance PCCD's visual representation of data, and facilitate the identification of data patterns, particularly at the sub-state level (counties, municipalities, school entities, etc.).

The 18-month Special Emphasis project will allow the SAC to communicate a better understanding of assessed offender criminogenic risk to practitioners and decision makers within Pennsylvania's county probation and parole system. The project will be significant in informing the county probation and parole system of the predictive accuracy of ORAS assessments on recidivism outcomes to better enhance community public safety. Additionally, a review of ORAS utilization will develop "best practices" surrounding its implementation to encourage cross-county uniformity in assessment usage, effectiveness, and fidelity. As a result, this Special Emphasis project intends to achieve consistent risk-determination across Pennsylvania counties to better inform statewide strategies and resource allocations, and an individual county's risk reduction programming to maximize gains in recidivism reduction.

(2) the associated provisions in 8 U.S.C. 1324a(a)(1) that, generally speaking, make it unlawful, in the United States, to hire (or recruit for employment) certain aliens.

C. Provide training (to the extent necessary) to those persons required by this condition to be notified of the award requirement for employment eligibility verification and of the associated provisions of 8 U.S.C. 1324a(a)(1).

D. As part of the recordkeeping for the award (including pursuant to the Part 200 Uniform Requirements), maintain records of all employment eligibility verifications pertinent to compliance with this award condition in accordance with Form I-9 record retention requirements, as well as records of all pertinent notifications and trainings.

When requested by BJS, the recipient agrees to provide to the Justice Research and Statistics Association (JRSA) and BJS information on automated data sets which are maintained by the recipient, or which are maintained by other agencies in the state and have been used successfully by the recipient in the past two years for analytic or statistical purposes. The information to be provided for each data set is indicated on the Infobase of State Activities and Research (ISAR) data collection form. To the extent that they are readily available, lists of data elements and/or code books also should be provided. If the recipient already has provided BJS or JRSA with this information, submission will cover only new data sets and the updating of previous data.

### 39

Copies of any published reports funded in whole or in part by this cooperative agreement must be provided directly to BJS and JRSA. The recipient will enter complete and accurate information regarding activities funded by this agreement in the online Infobase of State Activities and Research (ISAR) that is maintained by JRSA.

### 40

Within 45 calendar days after the end of any conference, meeting, retreat, seminar, symposium, training activity, or similar event funded under this award, and the total cost of which exceeds \$20,000 in award funds, the recipient must provide the program manager with the following information and itemized costs:

- 1) name of event;
- 2) event dates;
- 3) location of event;
- 4) number of federal attendees;
- 5) number of non-federal attendees;
- 6) costs of event space, including rooms for break-out sessions;
- 7) costs of audio visual services;
- 8) other equipment costs (e.g., computer fees, telephone fees);
- 9) costs of printing and distribution;
- 10) costs of meals provided during the event;
- 11) costs of refreshments provided during the event;
- 12) costs of event planner;
- 13) costs of event facilitators; and
- 14) any other costs associated with the event.

The recipient must also itemize and report any of the following attendee (including participants, presenters, speakers) costs that are paid or reimbursed with cooperative agreement funds:

- 1) meals and incidental expenses (M&IE portion of per diem);
- 2) lodging;
- 3) transportation to/from event location (e.g., common carrier, Privately Owned Vehicle (POV)); and,
- 4) local transportation (e.g., rental car, POV) at event location.
