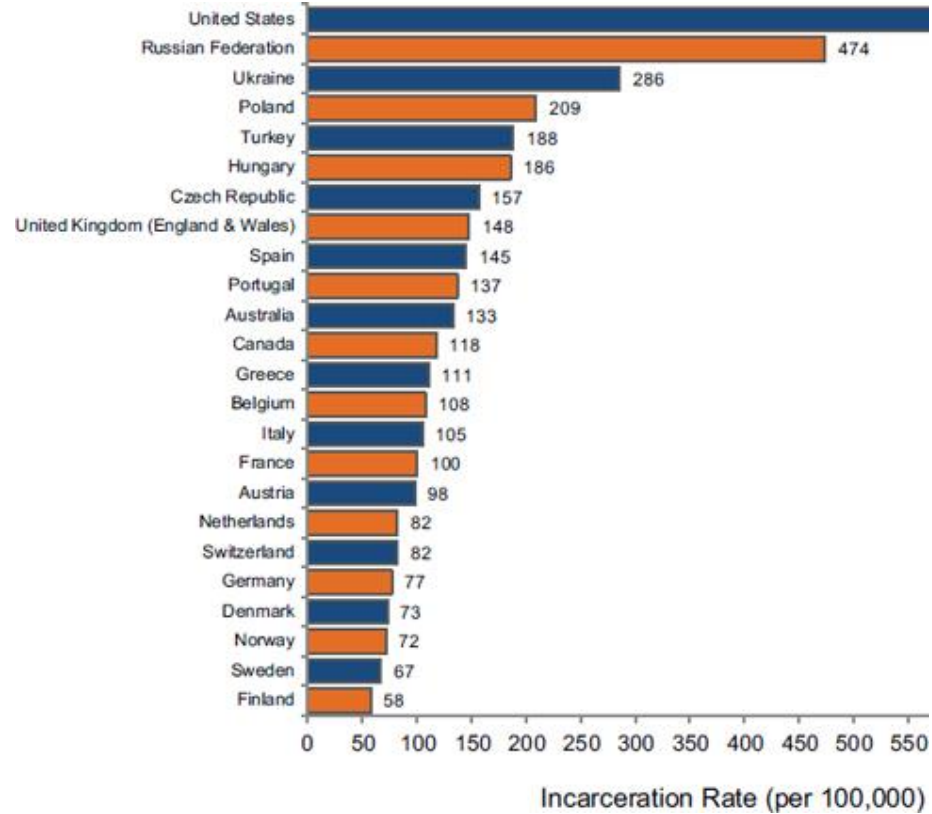

Death Penalty & Life Without Parole

Death Penalty

- 27 states that practice the Death Penalty also offer Life Without Parole as a sentencing alternative.

Life Without Parole

- 22 states that do not practice the Death Penalty offer Life Without Parole.

Alaska is the only state not practicing the Death Penalty or Life Without Parole.
