## Stepping Up Initiative Advance the six program objectives:

- Secure committed team leadership.
- Ensure implementation of timely screening and assessments.
- Obtain baseline data.
- Complete a comprehensive process analysis and inventory of services.
- Prioritize policy, practice and funding improvements.
- Identify strategies to track and evaluate progress.

- Employ Successful Strategies to reduce the need for incarceration.
- Expand training, education & awareness efforts to improve public perception & understanding.
- Provide effective supports and services to reduce entry into the criminal justice system & to improve outcomes for re-entry.
- Understanding special populations & unique circumstances.
- Address the needs of returning veterans.
- Research larger policy issues and develop longer range policy strategies to assist county efforts.

- Employ Successful Strategies to reduce the need for incarceration
  - Improve/Expand Effective Diversion Program developed due to increased calls to MH/DD regarding MH clients in the forensic system.
  - Apply Sequential Intercept Mapping at any intercept.
  - Develop Effective Forensic Program(case management, forensic peer support, provider network) to support MH/DD/D&A individuals.

- Expand training, education & awareness efforts to improve public perception & understanding
  - Improve Education and Awareness for public, stakeholders, families, providers, EMS, first responders & educators - Mental Health First Aid to increase awareness.
  - Improve training for mental health staff (case management, outpatient, peer supports, etc.).

- Expand training, education & awareness efforts to improve public perception & understanding
  - Improve and expand Law Enforcement training
    - · Mental Health, Trauma, Veterans, PTSD
    - Hostage Negotiation, De-Escalation, Listening Skills, Diagnostic Awareness, Differences in Juveniles, Delivery of Death Notices
    - Autism and Developmental Disabilities
    - Tactical Responses for police by police
    - Operation Sidewinder for Corrections Staff

- Provide effective supports and services to reduce entry into the criminal justice system & improve outcomes for re-entry
  - Increase awareness of the Diversion and Forensic Programs thru outreach to the Courts, Offices of the District Attorney, Public Defender, Probation, Law Enforcement, etc.
  - Divert the individual to treatment alternatives vs. incarceration with the support of all the entities mentioned above.
  - Improve interaction through education of the Judicial System, open lines of communication between departments – MH/DD and the DA, PD, Courts, District Justices, etc.
  - Improve access to affordable housing with supports for re-entering inmates and those identified for diversion.

- Understanding special populations & unique circumstances
  - Successful diversion from jail and reduced recidivism for veterans, individuals with mental health symptoms, Autism.
  - Develop alternatives for the developmentally disabled population by working with providers and Law Enforcement.
  - Appropriate use of the Mental Health, DUI, Veterans and D
     & A Courts.
  - Educate responders to see the value of gender/age specific responses.
  - Meet the needs of the juvenile population.

- Address the needs of returning veterans
  - Develop effective diversion to Veterans Court.
  - Develop a community approach to assisting returning veterans and create supports and linkages.
  - Partner with County Dept. of Veterans Affairs and the Berks Community Foundation as well as the Lebanon VA.

- Research larger policy issues and develop longer range policy strategies to assist county efforts
  - Utilize Cross Systems Mapping to guide the growth and development of the Forensic and Diversion Programs – plan to add Forensic Peer Specialists.
  - Seek Stakeholder Feedback at Provider Meetings and Police Trainings – requests for additional police training specific to Autism, De-Escalation, CIT.
  - Track recidivism through local statistics to identify reasons and possible alternative approaches.

## Berks County Cross-Systems Mapping

- Forensic services can assist at any Intercept:
  - Intercept 1 Law Enforcement and Emergency Services
  - Intercept 2 Initial Detention / Initial Court Hearing
  - Intercept 3 Jails / Courts
  - Intercept 4 Re–Entry
  - Intercept 5 Community Corrections / Community Support

### **Crisis Services**

- A contracted service funded by the Berks County MH/DD Program.
- Crisis services are available to anyone in Berks County 24 hours per day, 7 days a week.
- The Department is staffed with 18 Crisis Interventionists who will answer the phone live 24/7/365. 3 Supervisors on staff and 24 hour supervisory back up coverage.
- Staff are located at the 6<sup>th</sup> Street location, central to most areas in the county.
- Provide mobile, telephone, walk-in and texting services with a Goal to leave within 10 minutes.

### **Crisis Services**

- All Crisis Staff have 2 roles in the department:
  - Crisis Interventionist
  - Crisis MH Delegate
    - Bachelor level
- Texting is an added access point into services and not meant to replace any current service
  - Allows users another way to access crisis services
  - Our continuing goal is to have face-to-face or phone conversation with those we interact with via text
  - Crisis texting began in September 2016

Program is accredited by CARF and AAS

### **Crisis Services**

- Director/ Associate Director do outreach to Law Enforcement and the Community often accompanied by the MH Diversion Specialist:
  - Outreach to local Law Enforcement, through roll call visits, printed information.
  - Outreach to District Justices Offices.
- Presentations to First Responders.
- Presentations at Law Enforcement Trainings.
- Respond to calls in conjunction with Police, EMS, Area Agency on Aging, Diversion Specialist, etc.
- Assist in facilitating diversions.

#### Need for Diversion

- Berks County has a population of MH/DD clients who are involved in the criminal justice system.
- National Research indicates treatment and Forensics Mental Health Diversion is more successful than incarceration.
- Individuals with Mental Illness stay in jail much longer, without viable supports.

- Established January 2012 through a collaboration between Berks Connections/Pretrial Services (BCPS) and Berks County MH/DD Program to:
  - Decrease the incarceration rate of our non-violent mentally ill population by diverting them from jail and linking them to appropriate treatment services, monitoring and supervision through BCPS when applicable.
  - Maintain community safety only non-violent individuals are chosen.
  - Save taxpayer money by reducing incarceration and justice system costs.

#### Program Goals

- To decrease incarceration rate of the non-violent mentally ill population and maintain community safety.
- Diverting the individual to treatment alternatives vs. incarceration.
- To decrease the amount of resources expended on the above population.

#### **Program Statistics January 2012 to January 2018**

Total Number of Referrals to the Program:	791

#### **Forensic Transitional Housing Program**

- Established December 2012 with capacity to house 4 individuals in supervised setting for 2 groups of consumers:
  - Persons who would be unnecessarily incarcerated due to the absence of available housing.
  - Incarcerated individuals who could be released on parole if housing was available.
- ▶ PA Commission on Crime & Delinquency Grant

#### **Forensic Transitional Housing Program**

Total number accepted into this program to date – 69

- ▶ Individuals with dual diagnosis (MH & D&A) 50
- ▶ Individuals with a Serious Mental Illness(SMI) 28
- Individuals with a Felony Charge 11
- ▶ Individuals with a Summary Charge 64
- ▶ Individuals who have completed the program 36
- ▶ Evictions from the Program 15
- $\triangleright$  Elopements 5
- ▶ Voluntarily Withdrew 9
- $\rightarrow$  Death 1
- Current number participating in the program 3

# Forensic Blended Case Management (BCM)

#### Mission

- Link individuals to services.
- Ongoing collaboration.
- Diversion to higher levels of care as needed.
- Foster independence.
- Development of individualized service plans.

# Forensic Blended Case Management (BCM)

- 4 Forensic BCMs and 1 Forensic BCM Supervisor
- Eligibility
  - Medium-high risk offenders
  - Documented Mental Health diagnosis
  - Supervision with County or State Probation/Parole
  - Incarcerated within the Berks County Jail System or a State Correctional Institution who will be released within 30 days
  - Services are voluntary

## Forensic Peer Specialists

- Trained professionals with lived experience who are referred to work side-by-side with an individual.
- Peers work with individuals 1:1 or in a group setting to promote recovery and encourage compliance.
- Emphasis is placed on W.R.A.P. (Wellness Recovery Action Plan).
- Services are voluntary.

### **Provider Coalition**

- Comprised of various law enforcement officials and representatives from community agencies and the County.
- Designed to incorporate professionals from:
  - Medical services
  - Psychiatric services
  - Law enforcement
  - Housing providers
  - Educational services
  - Drug & alcohol services
  - Workforce development professionals

### **Provider Coalition**

#### Goals of the coalition

- Improve collaboration among community partners
- Work together to establish strengths within our current system.
- Collaborate to discuss areas of need for improvement.
- Work to establish new resources and programming for the forensic population with MH diagnoses
- Ensure that all parties are communicating to incorporate all necessary services to promote individuals' recovery.

### Data Driven Justice Initiative

- Plan to secure a contract with the Open Lattice System to collect data
- Requesting the use of Retained Revenues for financial support of the Initiative
- Will consult with several EMS Providers to pull their data for start up

### Forensic Services Summary

- We will continue to build the forensic programs using the Stepping Up Initiative in conjunction with the Comprehensive Behavioral Health Task Force, Cross Systems Mapping and the Data Driven Justice information.
- Forensic Diversion Specialist, Blended Case Managers and Peer Supports will coordinate efforts to improve overall outcomes of diversion, recovery and decreased recidivism.
- The Forensic Provider Network is both collaborative and comprehensive and will continue to grow with new programming and providers.
- Work with Law Enforcement and EMS to keep communication open and utilize treatment rather than incarceration when appropriate.
- The common goal is to divert individuals when feasible, assist them during their re-entry into the community and support their journey towards recovery.
