2022 SHERIFF AND DEPUTY SHERIFF CONTINUING EDUCATION

Continuing education is required every year and is delivered online through Temple University's Canvas Learning Platform.

All currently certified and active sheriffs and deputies have a new certification date until December 31, 2022. All personnel will have from January 24, 2022 until November 18, 2022 to complete 10 hours of online continuing education to recertify through December 31, 2023. This training consists of the following subjects:

Legal Updates	2 hours
Domestic Violence Awareness	3 hours
Court Security	5 hours

Each subject will have an exam. Per Board policy, each exam will require a 70% to pass and there will be one retest allowed for each exam failed. Should a student fail any exam twice or does not successfully complete the full continuing education training (10 hours) by November 18, 2022, the employing sheriff will have to request, through PCCD, re-enrollment for the student. There will be no certification time extensions due to test failures or failure to complete the training on time.

At the completion of continuing education training and after the grades are submitted and accepted for each student, an electronic reimbursement form will be generated through the Sheriff and Deputy Sheriff Information System (SDSIS). A flat hourly rate for each student for 10 hours of training will be authorized. No mileage or meals will be reimbursed. As a reminder, although the Board has started to repay reimbursements, it may be some time before these reimbursements will be addressed. Counties still need to submit the reimbursement request within 18 months of the date the form was issued or the reimbursement will expire. Once submitted, the form is locked in, and will be considered by the Board when the Board takes up those reimbursements.

Temple requires that you change your Canvas password every ten months. Depending on when you originally created or last changed your password you may have to change it before accessing the Canvas learning platform. Instructions on how to change your password are contained in the updated Canvas Help Guide. You will need the TUID # Temple provided you at the beginning of this process.

Please note: The Temple Canvas password is NOT your Keystone password. The Temple Canvas password is specific to that website.



As a reminder, there are certain hardware and software requirements for utilizing the Canvas Learning Platform. Those are outlined on the following table. If you utilize a system that does not meet these minimum requirements some or all of the applications may not function.
